2ND LEVEL



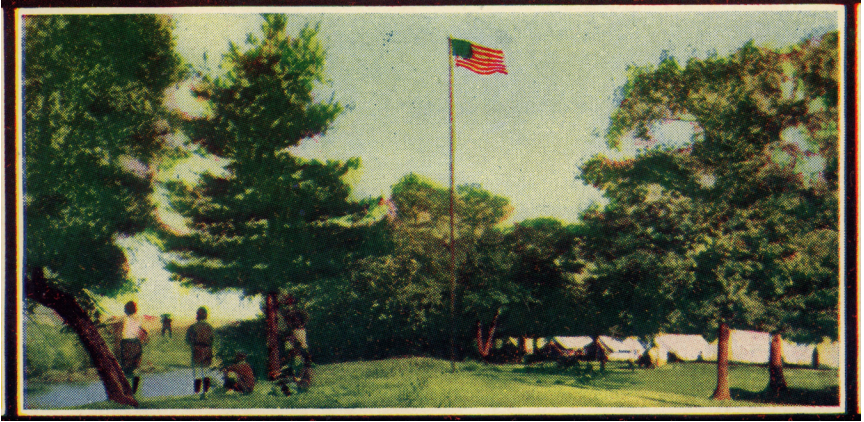

Shortly after Northern Star Scouting acquired Base Camp in 2008, John Andrews was approached by Sydney Beane, who was representing the Dakota community on a task force. Syd shared that his great-uncle Dr. Charles Eastman was the grandson of Seth Eastman, who at one time was commander of Fort Snelling - and the grandson of Chief Cloud Man, who died in the internment camp at Fort Snelling during the Dakota War of 1862. Further, Syd shared that his great uncle, whose childhood name was Ohiyesa, was one of the founding influences and leaders of the Boy Scouts, and he asked if Scouting could tell the story of this amazing man with deep roots in this region. We are honored to do so.
